Severability Should any term of this Agreement be finally determined by a court/arbitrator/mediator of competent jurisdiction to be invalid, unenforceable or otherwise contrary to law and equity, the parties agree that such provision shall be construed, limited, modified or, if necessary, severed, to the extent necessary to eliminate its invalidity or unenforceability, and that the other provisions of this Agreement shall remain unaffected. Liability - The maximum liability of Webrageous Studios related to or in connection with this agreement will be limited to the total amount paid by the customer in the year of any dispute. Webrageous Studios shall not be responsible for loss of profits or revenue. It is understood that this agreement is made with Webrageous Studios, LLC only. This agreement is not made with any employees or members of Webrageous Studios, LLC. Agreement Not To Hire - Client (and its subsidiaries and parent companies) and Webrageous agree not to offer employment or subcontract work to each others known employee(s) or known contractors/subcontractors during the period of this contract and for a period of 3 years after this agreement ends. Both parties agree to do everything possible to prevent the others employees or contractors from being hired by clients. This Agreement will be governed by and construed in accordance with the internal laws of the State of Utah, excluding that body of laws known as choice of law or conflict of laws. All claims must be brought in the parties' individual capacity, and not as a plaintiff or class member in any purported class action, collective action, private attorney general action or other representative proceeding.
